Date for oral submissions in Review on the Record

Victoria - The Office of the Police Complaint Commissioner wishes to advise that oral submissions for the review into the findings of a discipline proceeding relating to an allegation of discreditable conduct against Constable Neil Logan of the Vancouver Police Department, will be held on Tuesday, October 6, 2020, beginning at 9:30 am.

Due to the ongoing public health emergency surrounding the COVID-19 pandemic, these oral submissions will proceed through a video conference with the participants. In the interests of transparency and public accessibility to this process, the proceeding will be audio recorded and posted to the OPCC website shortly after the conclusion of the hearing, unless an order is made by the adjudicator prohibiting or limiting access to information contained in the proceeding.

- Discipline Authorities are generally senior ranking police officers who are required under the *Police Act* to make determinations regarding the investigation and discipline of police officers alleged to have committed misconduct.
- A Review on the Record is a form of adjudicative review in which the adjudicator, a Retired Judge, conducts a “paper review” of all evidence and materials from the investigation and discipline hearing. The adjudicator may also receive submissions from the respondent’s counsel, the Police Complaint Commissioner’s counsel, the complainant and the Discipline Authority before rendering his/her decision. - An adjudicator must determine whether there is misconduct and, if so, determine the corrective or disciplinary measures to be imposed. The adjudicator’s decision at a Review on the Record is final and conclusive. In some cases, reviews can be focused solely on the issue of the discipline imposed.
