**Release of Decision Rescheduled for Victoria Police Officer Public Hearing**

**Victoria** – The Public Hearing into the circumstances involving Sergeant Ron Kirkwood of the Victoria Police Department following the death of Ms. Lisa Rauch in 2019 will reconvene on Monday May 26, 2025. It is expected that retired B.C. Judge Wally Oppal, Adjudicator for this Public Hearing, will deliver his ruling. The hearing is scheduled to take place at 10:00 am - 947 Fort St., Victoria, BC, second floor.

The Adjudicator will be required to determine whether Sergeant Kirkwood committed misconduct in relation to the discharge of ARWEN rounds that struck Ms. Rauch and whether the failure to complete required documentation following the death of Ms. Rauch amounted to misconduct.

The Adjudicator may also make recommendations to the Chief Constable or Police Board concerning any changes in policy or practice they consider advisable.

**About the OPCC and Public Hearings:**

- The OPCC initiates mandatory *Police Act* investigations whenever death or serious harm results from an incident involving municipal police officers or in instances where someone is in the care or custody of police. These investigations are separate and distinct from investigations by the Independent Investigations Office (IIO) and are not restricted to evidence gathered by the IIO.
- A Public Hearing is not limited to the evidence and issues canvassed at the discipline proceeding. The Police Complaint Commissioner can appoint Commission Counsel to act on their behalf during Public Hearings.
- A retired judge is appointed to sit as the Adjudicator and review the evidence, hear sworn testimony, and arrive at a decision as to whether there is misconduct and, if necessary, determine the corrective and/or disciplinary measures to be imposed.
