Victoria – The Office of the Police Complaint Commissioner (OPCC) public hearing into allegations of police misconduct relating to the death of Myles Gray will resume on Wednesday, April 29, 2026, and continue over the coming weeks.

- May 8, 2026: start time 9:30 a.m.

The following hearing dates will take place in Room C575 at UBC Robson Square:

- May 19, 2026: start time 9:30 a.m.
- May 20, 2026: start time 9:30 a.m.
- May 21, 2026: start time 9:30 a.m.
- May 22, 2026: start time 9:30 a.m.

April 29 to May 1

- Continuation of evidence of Michael Massine, the public safety consultant called by public hearing counsel who started his evidence in March 2026.
- Evidence of Retired Sergeant John Roberts of the Vancouver Police Department (VPD), called by counsel for the Chief Constable of the VPD.
- Opening statements from counsel for the respondent members.
- Evidence of Constable Eric Birzneck, one of the respondent members.

May 6 to May 8

- Evidence of respondent members (specific dates for witnesses to be determined).
- Hearing of applications to be brought by two respondent members.

May 19 to May 22

- Evidence of respondent members (specific dates for witnesses to be determined).
- Evidence of other witnesses to be called by the respondent members.

Additional dates will need to be scheduled to allow for the completion of any remaining evidence and the making of closing legal arguments.

The Adjudicator, the Honourable Elizabeth Arnold-Bailey, has made an [Order on Access and Recording](#) in this case that, among other things, prohibits the audio or video recording of the proceeding, subject to certain limited exceptions for the media who may make audio recordings for the sole purpose of verifying their notes.

While the public hearing is underway, the OPCC will not provide comments about the merits of the case other than through its counsel at the public hearing.
